

MINUTES OF THE GENERAL MEMBERSHIP MEETING

July 29, 2020, 2:00 PM, via Online Platform

1. ATTENDANCE

The list of members present online, as represented by their respective authorized representatives and/or designated proxies, are listed in **Annex A** of these Minutes.

2. PRELIMINARIES, CALL TO ORDER, CERTIFICATION and NOTICE OF QUORUM

Prior to the meeting proper, an invocation was said, and a video of the Philippine National Anthem was played. Thereafter, the Chairman of the PEM Board, Mr. Noel V. Aboboto, called the meeting to order. He gave brief welcome remarks and introduced the Members of the PEM Board of Directors as well as the other participants who attended online. Next, for the Certification of Notices and Determination of Quorum, the Chairman asked Atty. Marian Venussa S. Santiago-Dela Fuente, Corporate Secretary if the notices of the meeting were sent to the members of the Company in accordance with the by-laws of the Company.

Atty. Dela Fuente confirmed that written notices of the meeting were sent to all members of record on July 24, 2020 by email. The notice was also published in the PEMC website at www.wesm.ph in accordance with the Corporation Code and the By-Laws of the Company. The rationale and explanation for each agenda item which require members' approval were also provided in the said notice.

The Chairman then asked whether a quorum for the meeting was reached. Atty. Dela Fuente confirmed this and certified that the attendance represents approximately more than fifty percent (50%) of the members of the Company and that therefore, a quorum for the meeting was reached.

Atty. Dela Fuente was then asked to read the ground rules that shall be observed during the meeting for fair, orderly, and efficient proceedings. She mentioned that any member who wishes to address the Board may submit their questions via the comment section in the live stream which shall be read aloud by the Corporate Secretary. All such questions must be accompanied with the name of the members and the company being represented. She also explained how the questions from the Members shall be entertained subject to certain conditions.

For the voting procedure, Atty. Dela Fuente said that the Company's sectoral membership entitles the holder to a vote in accordance with the allocation set out in the By-Laws of the Company. The affirmative vote of the members representing at least a majority of the total voting shares shall be needed to pass and approve each proposed resolution unless the law provides otherwise. As each item is taken up in the agenda, the Corporate Secretary will report on the votes received and tabulated as of 1:45 pm. She also said that the Minutes will reflect the final tally of votes. Voting will close when the meeting is adjourned.



HE mentioned that a copy of the minutes has been made available by publication in the Company's website within 24 hours from the conduct of meeting.

Atty. Dela Fuente presented PEMC Management's Resolution No. 2020-01, approving the Minutes of the Annual General Membership Meeting held on June 19, 2019 in Marco Polo Ortigas Manila. She proposed the adoption of this Management Resolution. At that point, she presented the members' votes received and tabulated as follows:

5. REPORT OF THE PRESIDENT

President Oscar E. Ala delivered the President's Report and the floor later was opened for discussion. The text of the President's Report is attached as **Annex B** of these Minutes. The Chairman asked Atty. Dela Fuente if any question was received from the Members as to this item in the agenda. Atty. Dela Fuente said there were none. The Chairman closed the discussion and proceeded to the next item in the agenda.

6. REPORT OF THE WESM GOVERNANCE COMMITTEES

The Wholesale Electricity Spot Market (WESM) Governance Committee (WGC) Chairpersons presented their respective accomplishments for 2019. Pre-recorded videos of the representatives and Chairpersons of each Committee were shown on the screen. First, the Dispute Resolution Administrator, Atty. Jesusito Morallos, presented his report on the WESM Dispute Resolution and the 2019 accomplishments of the DRA. Next, Engr. Francis V. Mapile, Chairperson of the Market Surveillance Committee, presented the highlights of MSC's accomplishments for 2019. Said report was followed by that of the PEMC Audit Committee, as its Chairperson, Prof. Felix Bustos presented their accomplishments. Thereafter, Atty. Maila De Castro, Chairperson of the Rules Change Committee presented the Rules Change Updates. Lastly, Prof. Jordan Rel C. Orillaza, Chairperson of the Technical Committee (TC), presented their accomplishments for 2019 as well as their Work Plan and activities.

7. THE CHAIRMAN'S ADDRESS

Chairman Noel Aboboto gave his Chairman's address. The text of the Chairman's address is attached as **Annex C** of these Minutes. After his speech, he asked whether there were any questions received from the Members. Atty. Dela Fuente confirmed that there were none.

8. RATIFICATION OF THE ACTS, RESOLUTIONS OF THE BOARD AND MANAGEMENT


Next on the agenda is the ratification and approval of the acts, resolutions and deeds of the Board of Directors, its Committees and Management of the Company since the Annual General Membership Meeting held on June 19, 2019. Chairman Aboboto first asked Atty. Dela Fuente if there were any questions received from the Members on this item in the agenda. Atty. Dela Fuente confirmed that there were none.

Atty. Dela Fuente presented Management Resolution No. 2020-02 and moved that the same be adopted by the Members. The text of the said Resolution states, "RESOLVED, that all acts, resolutions and deeds of the Board of Directors and Management of the Company from the Annual General Membership Meeting held on 19 June 2019 up to the date of this meeting be as they hereby are, confirmed, ratified and approved."

Atty. Marian Dela Fuente, Corporate Secretary, explained that she was seeking ratification of all the acts, resolutions and deeds of the Board, its Committees as well as all acts of Management which are provided in the minutes of the meetings of the Board, its Committees and Management. These also include the approval of market manuals, amendments to market rules, market fees, contracts and agreements, projects, treasury matters, and disclosures to the Securities and Exchange Commission, Energy Regulatory Commission and the Department of Energy. She further explained that acts of management pertain to those taken to implement the resolutions, directives and instructions of the Board and its Committees and those done in the regular course of the Company's business.

As to the voting results, Atty. Dela Fuente said that 100% affirmative vote from the Members present and voting were received and that therefore, the Motion has been approved and Resolution No. 2020-02 is adopted. The Corporate Secretary recorded the following votes for this agenda item as follows:

9. APPROVAL OF THE 2019 AUDITED FINANCIAL STATEMENTS

The next order of business was the approval of the Company's Audited Financial Statements for the period ended December 31, 2019. The Chairman asked Dir. Elenita D. Go, the company's Treasurer to give a summary of the Audited Financial Statements.

Dir. Go said that PEMC's External Auditor, Navarro Amper and Company (Deloitte Philippines) expressed that PEMC's financial statements present fairly, in all material respects, the financial position of the Company as at December 31, 2019, and its financial performance and its cash flow for the year ended in accordance with Philippine Financial Reporting Standards (PFRS).


For the Statement of Assets, Liabilities and Fund Balance, Total Assets of PEMC is Php 1.007 billion. A decrease from Php 1.891 billion last year due to the transfer of hardwares and softwares such as the NMMS and CRSS to Independent Electricity Market Operator of the Philippines (IEMOP). Total Liabilities for 2019 is Php 464.79 million pesos. An increase of around Php 390.00 million due to the set up of payable to the funds of IEMOP which is currently with PEMC. Remaining Fund balance of PEMC is Php 543.18 million after said transfers.

For Statement of Receipts and Expenses, Total receipts in 2019 is Php 297.44 million which include the collection of Market Fees, interest income on Time Deposits and Financial penalty for breaches in the WESM Rules. Total Operating Expenses for 2019 is Php 235.21 million pesos. These are day to day expenses that is incurred for the market administration and governance such as but not limited to personnel expenses, rental, utilities, honoraria, training etc. Total Receipts over Expenses for 2019 is Php 62.23 million pesos.

Atty. Dela Fuente presented Management Resolution No. 2020-03 recommending approval of the 2019 Audited Financial Statements and moving for the adoption of the

said Resolution by the Members. As to the voting results, Atty. Dela Fuente said that 100% affirmative vote from the Members present and voting were received and that therefore, the Motion has been approved and Resolution No. 2020-03 is adopted. The Corporate Secretary recorded the following votes for this agenda item as follows:


10. APPOINTMENT OF EXTERNAL AUDITORS

Annex B PRESIDENT'S REPORT

The Philippine Electricity Market Corporation as the governing body of the Wholesale Electricity Spot Market, ensures the effective and proactive governance of the power bourse to safeguard the interest and welfare of the Filipino consumers.

Since early 2018, PEMC has reshaped its identity focusing on its vision to become a Premier Electricity Market and Champion of Governance or PEMCGo.

Collectively, our MISSION is P-E-M-C – that is Power, Efficiency, Market, and Competition. These are all geared towards the achievement of the objectives of the market as provided in the EPIRA.

With the support of the PEM Board, WESM Governance Committees, WESM Members, and the policy-making and regulatory bodies, we are pleased to report the following accomplishments realized last year pursuant to our mandate...

Power

Our desire is for the market to be conducive to attracting new resources and investments to meet the growing demand of the Filipino consumers.

In 2019, PEMC, together with the Independent Electricity Market Operator of the Philippines or IEMOP, facilitated the certification audit of the New Market Management System and the Central Registration and Settlement System. The audit achieved near completion with the issuance of software certificates for key modules by the external auditor.

PEMC likewise participated in five (5) Energy Regulatory Commission hearings for the Price Determination Methodology petition.

Moreover, PEMC conducted consultation meetings with Market Participants to determine challenges, especially for the WESM Mindanao implementation. Together with the IEMOP, PEMC presented recommendations addressing commercial and operational concerns specific to Mindanao, and likewise participated in the conduct of WESM Mindanao Roadshows to boost awareness and participation of participants on the parallel operations programs.

As part of our strategy to provide and promote relevant market information to potential investors and current market players, PEMC also conducted various events in 2019, which were actively participated in by Market Participants and other interested parties. These include the first ever WESM Compliance Officer Summit and Electricity Market Exchange, which discussed the benefits and opportunities of introducing Electricity Derivatives market in the country.

Moreover, PEMC held 42 Compliance and Monitoring Assessment Conferences, 13 Compliance Trainings, 5 WESM Compliance Officer Accreditation Workshops, and 9 plant visits.

As you are aware, PEMC regularly publishes Market Assessment Reports to provide information and awareness among participants, interested parties, and partner agencies on the market results and performance. In 2019, we published:

- 12 Monthly Market Assessment Reports,
- 2 Quarterly Market Assessment Reports,
- 1 Annual Market Assessment Report,
- 4 Quarterly Retail Market Assessment Reports,
- 1 Annual Retail Market Assessment Report, and
- 9 Investigation Status Reports.

PEMC also presented its assessment and recommendations on the price spikes that occurred from April 10 to 15, 2019 to the Senate Committee on Energy.

Efficiency

PEMC aims to establish performance management framework on market and system operations and market governance functions to become one of the best in the global electricity markets. With this goal in mind, PEMC continuously monitors and reports the results of the Market Operator Performance Standards to the PEM Board and Department of Energy.

We also signed the PEMC-IEMOP Data and Information Exchange Protocol on October 1, 2019 to streamline the process of data exchange between the two organizations, and how data will be accessed, used, and disclosed by and between the Parties.

Market

With regard to the establishment of the Renewable Energy Market, PEMC, in coordination with the DOE and the United Nations Development Programme facilitated and approved the user acceptance test reports for the completion of the Philippine Renewable Energy Market System or PREMS.

Moreover, the main site and disaster recovery site for the PREMS were installed and configured successfully. PEMC likewise conducted pilot workshops for the RE Market participants and started the preparations for the ongoing participant registration.

Competition

To ensure the Market Participants' adherence to market rules and manuals, PEMC completed 91 preliminary notice of investigations. Of these, 130 cases were issued with investigation reports and 69 investigation reports were approved by the PEM Board. 23 cases were imposed with penalties.

PEMC also implemented a streamlined process wherein initial non-compliances undergo pre-assessment prior to endorsement for investigation. In 2019, PEMC investigated a total of 133 cases composed of 57,680 intervals, about two percent (2%) of which was found in breach for the Must-Offer Rule and less than one percent (1%) for the Real-Time Dispatch.

PEMC likewise initiated a rule change proposal for the WESM Compliance Officers Accreditation and developed the Guidelines for the Offer for Settlement, which were duly approved by the Market Surveillance Committee on May 20, 2019.

The past year was marked by these notable achievements. I believe that the burning enthusiasm and commitment of PEMC's Management and staff will prove to be instrumental in making PEMC a Premier Electricity Market and a true Champion of a multitude of opportunities for growth in the spot market and the entire power industry.

With our concerted efforts – yours and ours – we truly believe that together, we will achieve increased accessibility to electricity, spur market growth, and sustain industrial and economic prosperity.

A – Anti-Competitive Behavior Framework Formulation

As part of our goal to have an efficient market competition, we also aim to study and formulate an anti-competitive behavior framework in the WESM.

D – Derivatives Market for Electricity

This year, we have already commenced climate scanning activities to gauge the participants' appetite, knowledge, and concerns on the proposed development of a derivatives market for electricity in the country. We will also coordinate and seek policy direction and regulatory advice from the DOE and ERC.

I – Integrated Management System Certification

To ensure the quality of services that we provide to our customers and perform our business within internationally accepted standards and practices, PEMC seeks to be certified with ISO 9001 and ISO 27001 this year.

A – Audit of Market Operations and Metering Review
