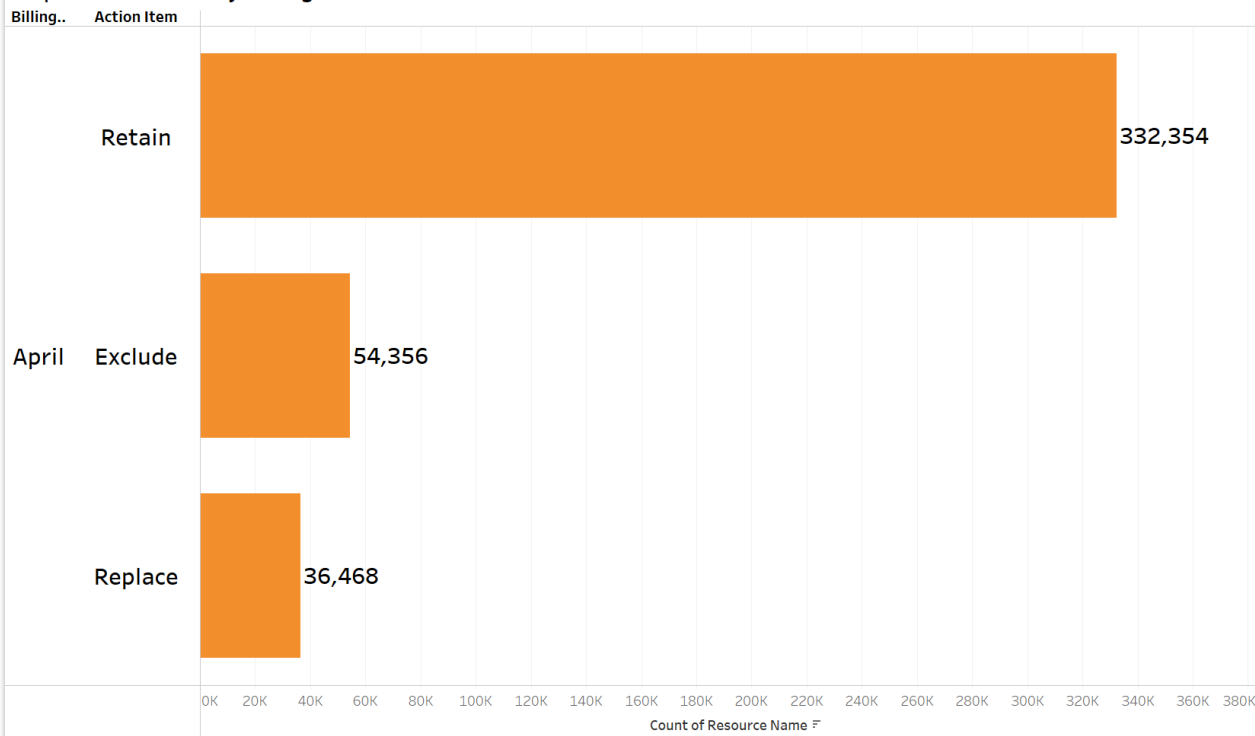

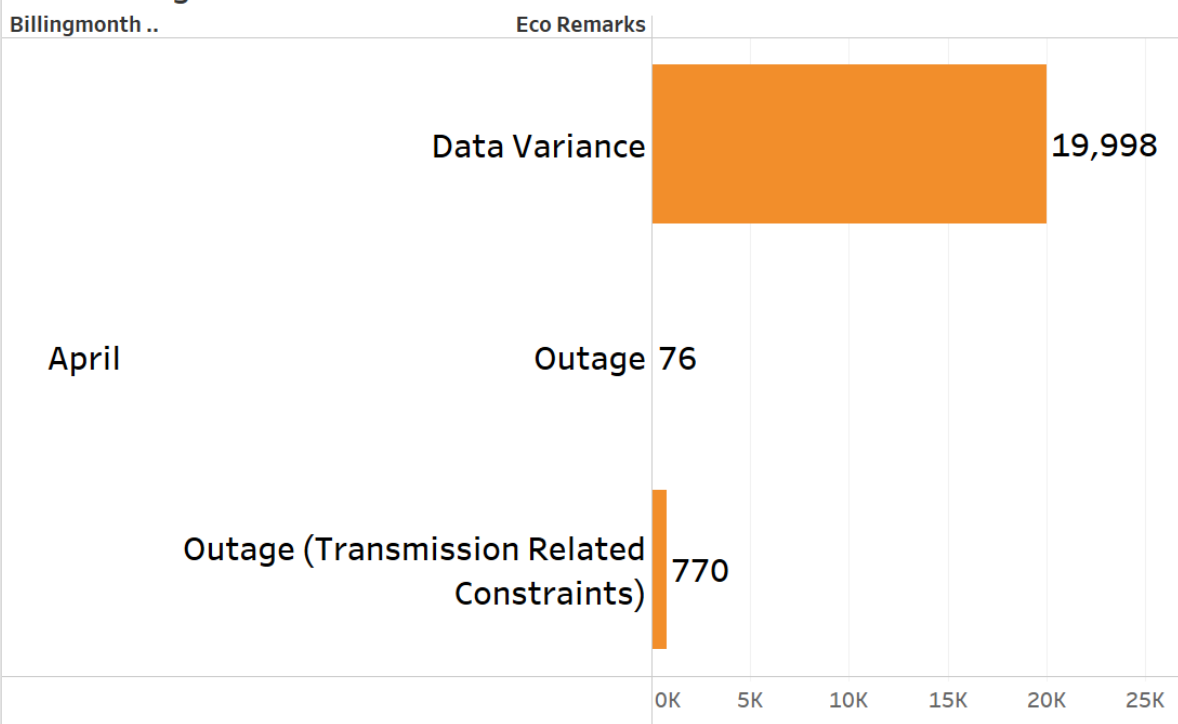
As of April 2023, there are **95** facilities registered as MDGU in the WESM. From the registered facilities, **91** facilities from Luzon, Visayas, and Mindanao regions are being monitored; **4** facilities are under test and commissioning (T&C); the Mindanao plants/facilities are now being monitored after the declaration of commercial operation of the WESM Mindanao on 26 January 2023. (*DOE DC2022-12-0039, 23 December 2022*).

Requested Actions by Billing Month

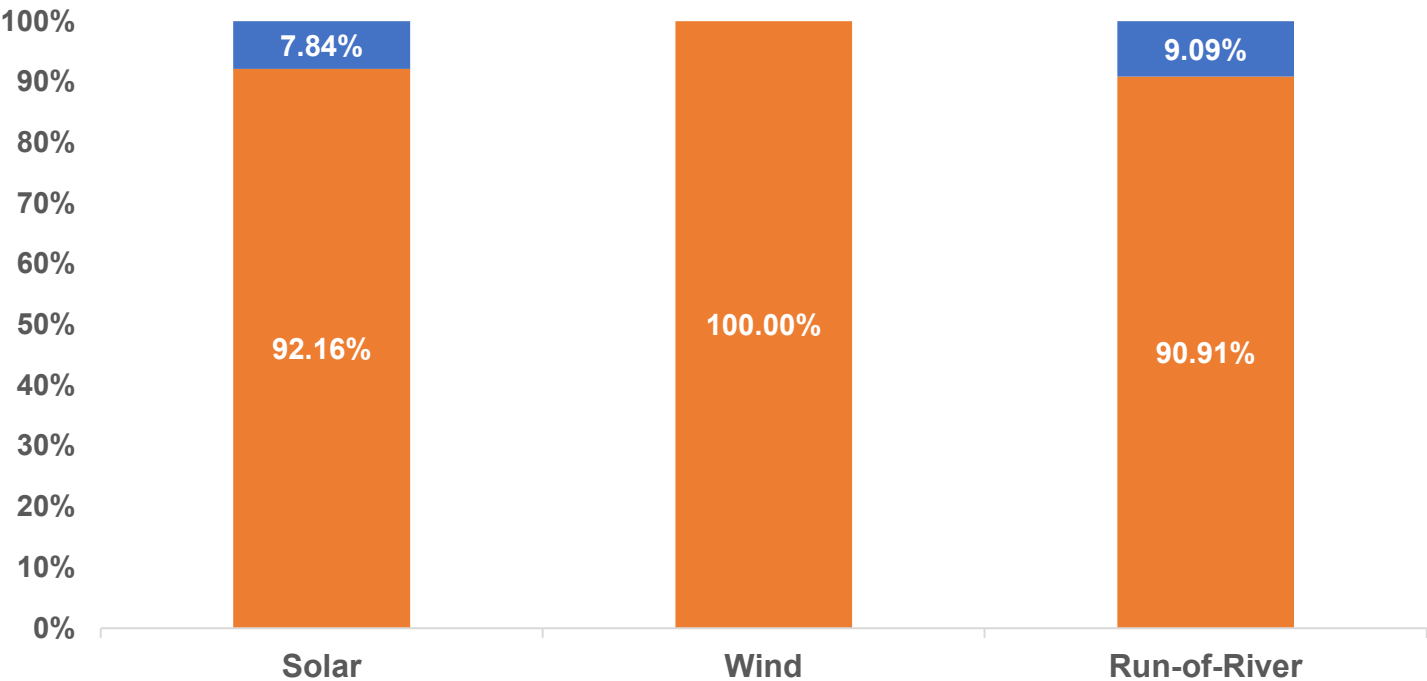
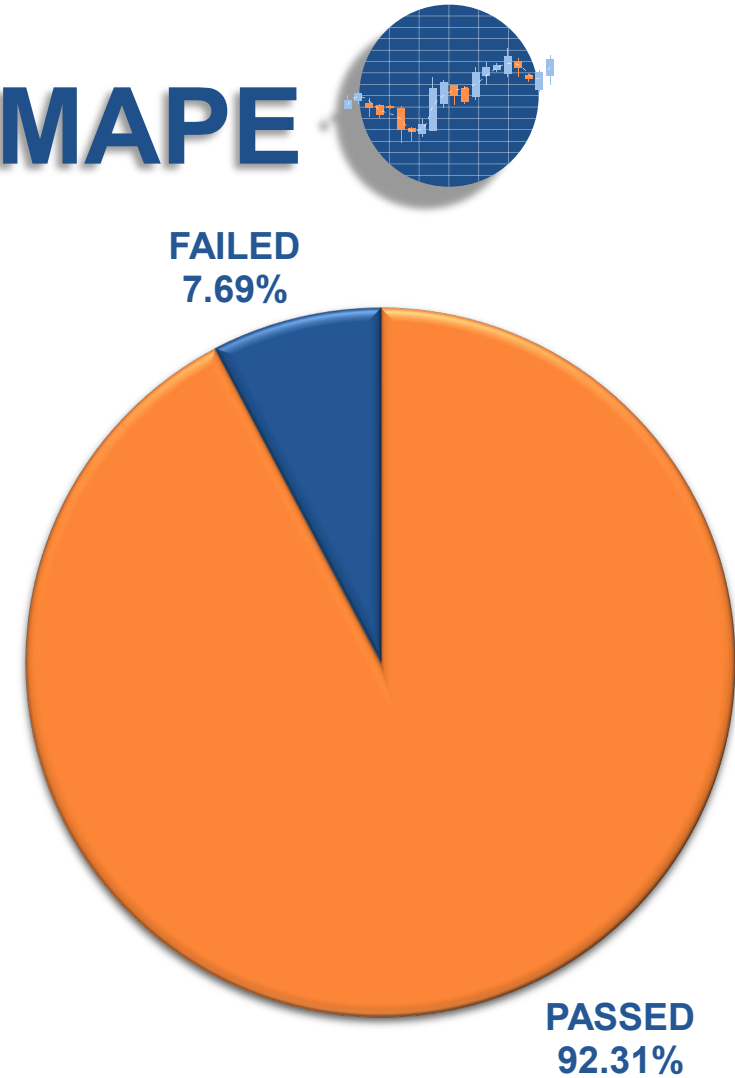


Event Categories



- ECO received a total of **54,356** intervals requesting exclusion and a total of **36,468** intervals requesting replacement due to possible Data Variance.
- The ECO also received a total of **332,354** intervals to retain results.
- Out of **54,356** intervals requesting exclusion, the ECO accepts **846** intervals (**1.56%** of the total intervals for exclusion).
- Out of **36,468** intervals requesting data replacement, **19,998** intervals were confirmed to be Data Variance (**54.84%** of the intervals for replacement).

APRIL 2023 FINAL FAS RESULT (OVERALL PASSING RATE)

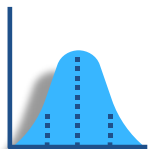


83 out of 91 facilities being monitored performed within the MAPE standards while 8 failed.

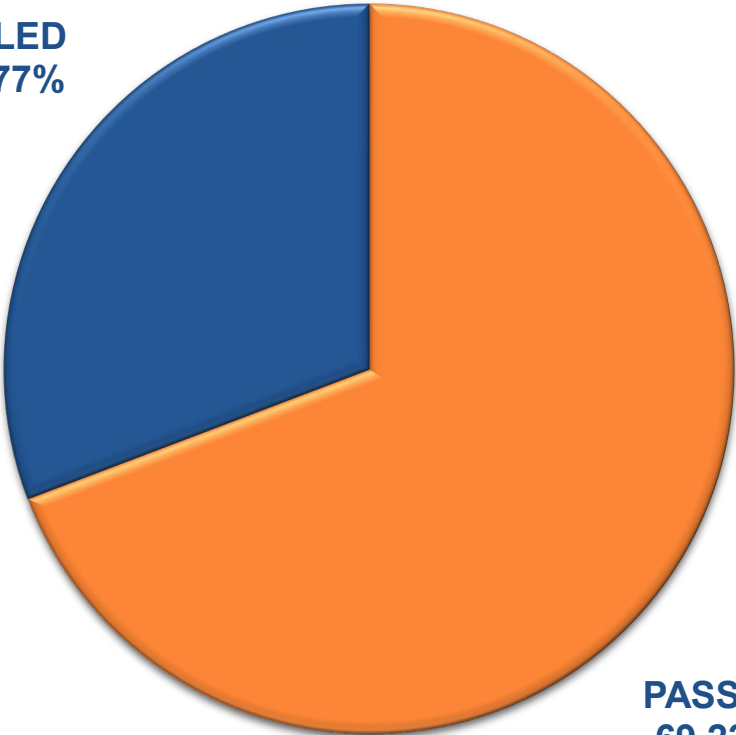

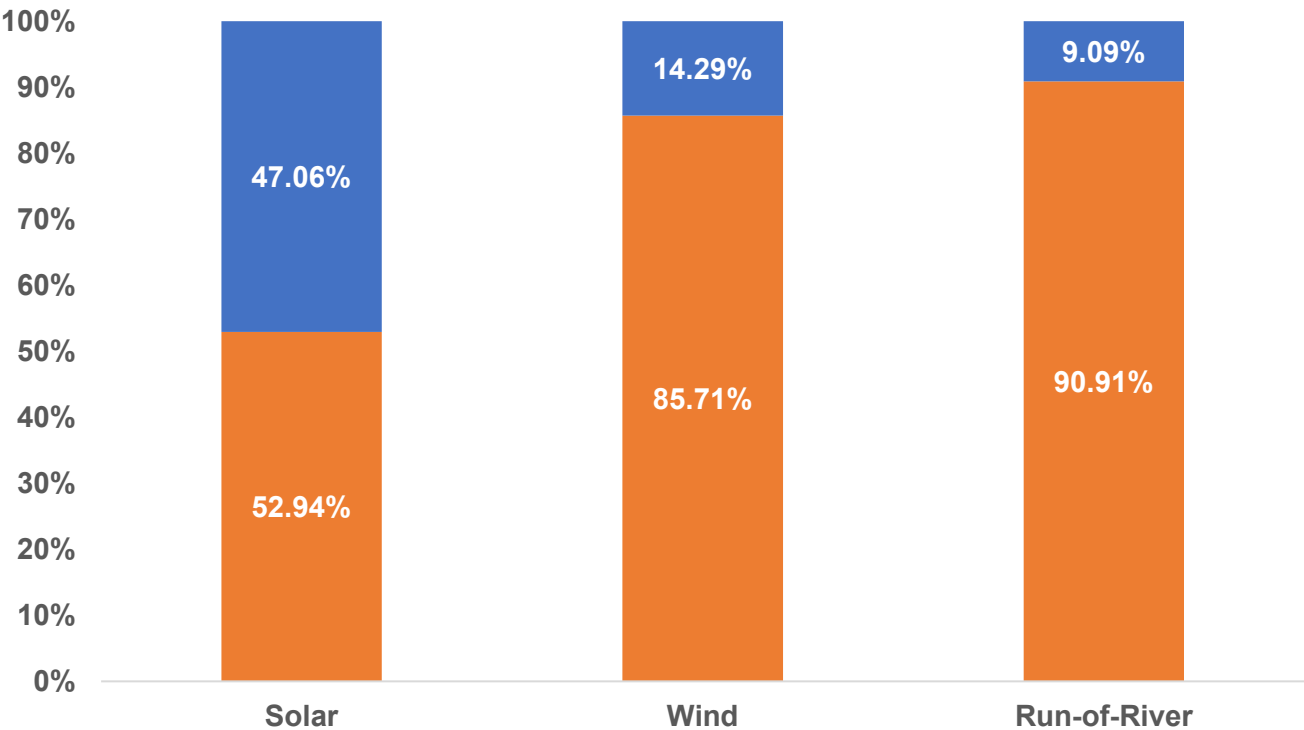

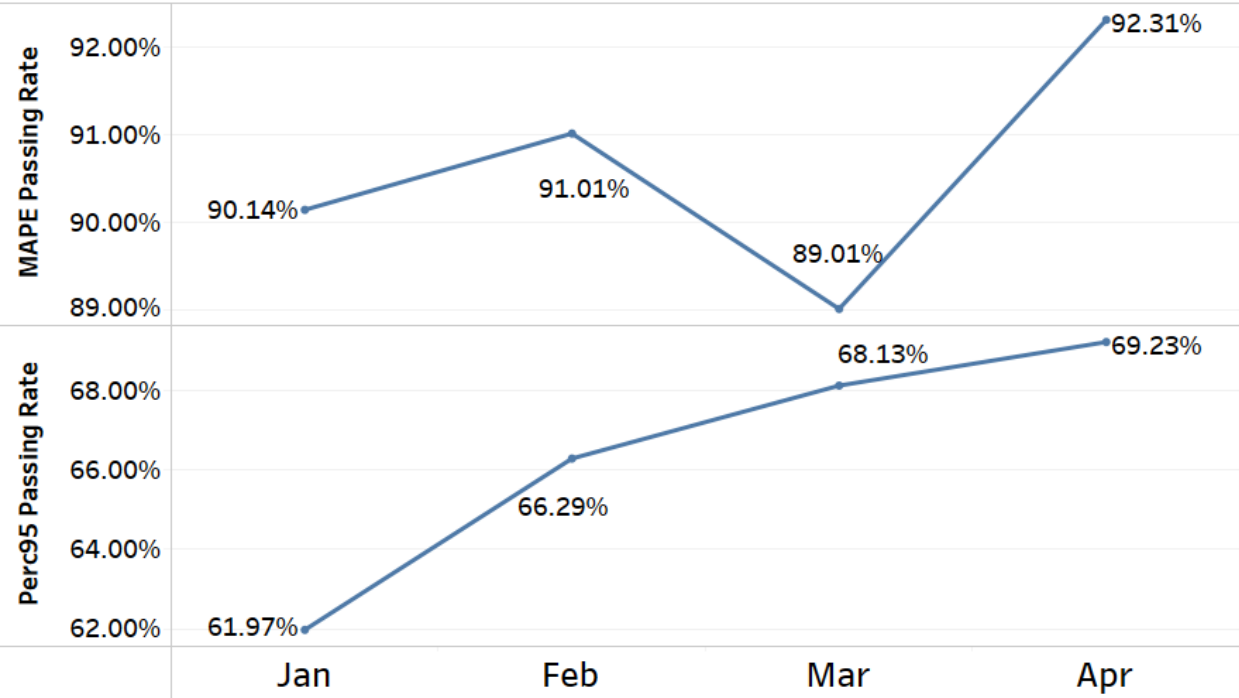


- 63 out of 91 facilities being monitored performed within the PERC95 standards while 28 failed.

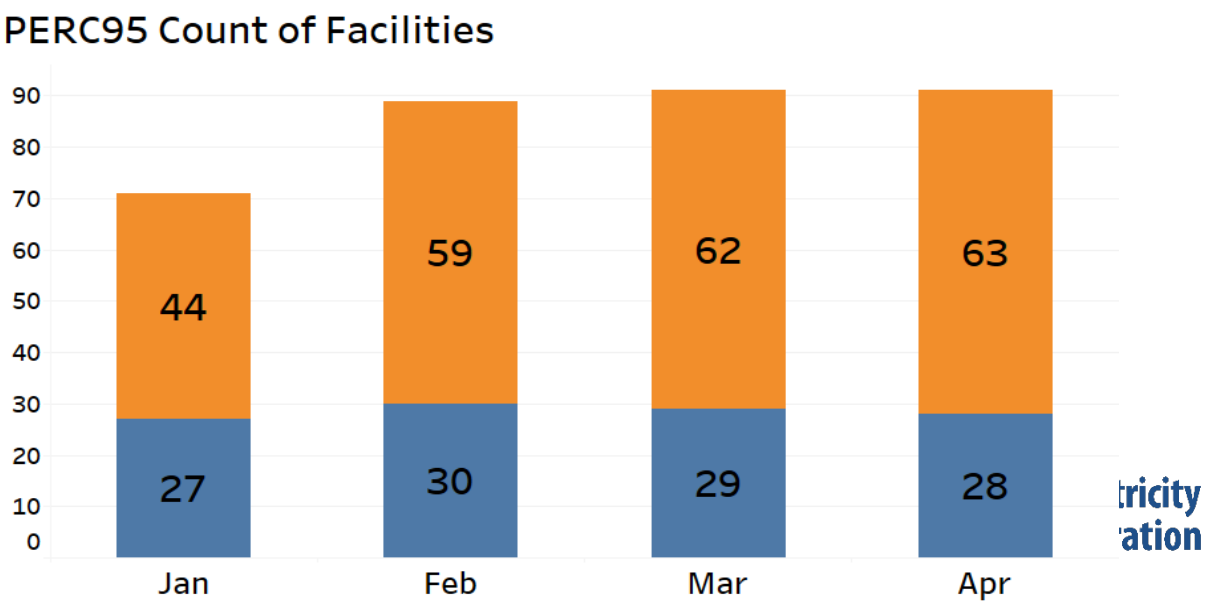
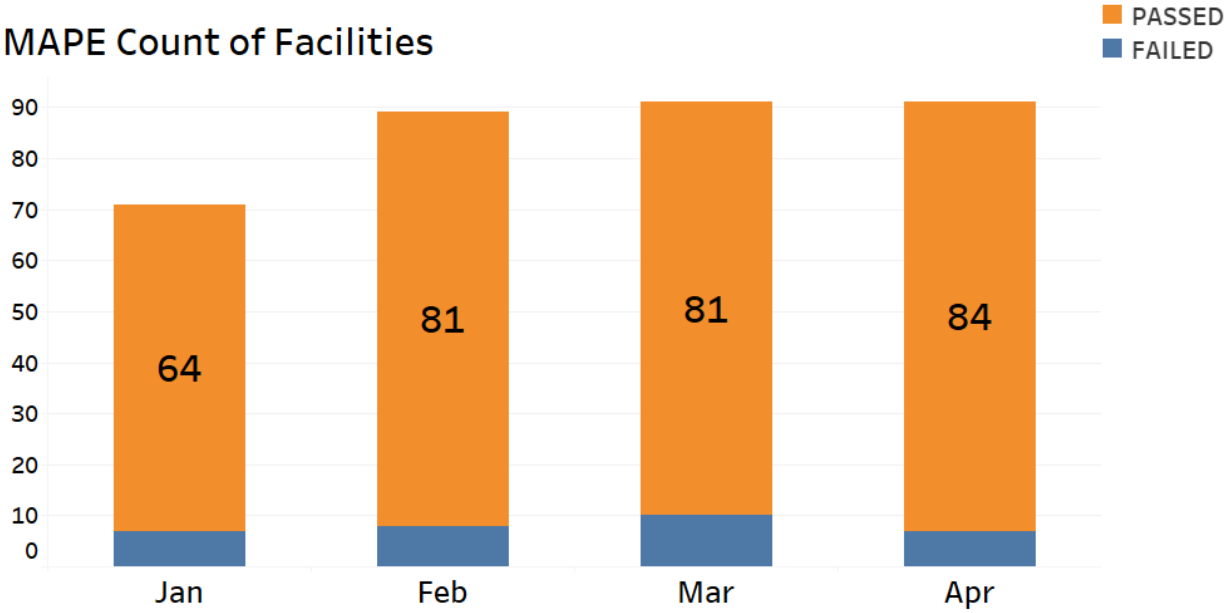
APRIL 2023 FINAL FAS REPORT (OVERALL PASSING RATE)



2023 PASSING RATE TREND



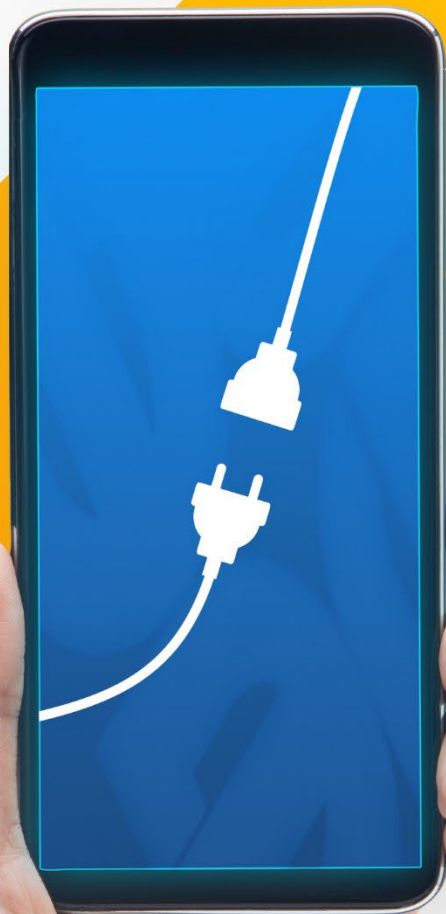
- The MAPE passing rate trend improved from 89.01% in March 2023 to 92.31% as of April 2023.
- The PERC95 passing rate continuously increasing since January 2023, from 61.97% to 69.23% as of April 2023.
