RESOLUTION NO. 2012-05

**Proposed Changes to the WESM Rules Provision on Notice of
Non-approval of Application for Registration as WESM Member**

WHEREAS, Clause 2.5.6 of the WESM Rules provides for the procedure to be followed by the Market Operator in case of the denial of an application for registration as a WESM Member;

WHEREAS, in a Decision dated 19 September 2011, the Energy Regulatory Commission (ERC) directed the Philippine Electricity Market Corporation (PEMC) to amend Clauses 2.5.6.1 and 2.5.6.2 of the WESM Rules, mandating the PEMC, in all circumstances, to furnish a copy to ERC of the denial of an application for membership in the WESM;

WHEREAS, pursuant to the directive of the ERC, the PEMC submitted on 07 May 2012 to the Rules Changes Committee (RCC) its proposed changes to said Clauses of the WESM Rules, which are summarized as follows:

- a. In case of denial of an application, whether due to the applicant's failure to meet the requirements for the WESM membership category applied for or for any other reason, the Market Operator must send written notice to the applicant; and
- b. Such notice shall always be provided to the ERC, irrespective of the reason;

WHEREAS, during the 61st RCC Meeting on 09 May 2012, the proposed changes were presented to the RCC, for discussion;

WHEREAS, as agreed upon by the RCC during the said 61st Meeting, thereafter on 09 May 2012, the rules change proposal was published in the WESM website to solicit comments from the market participants and other interested parties;

WHEREAS, during the period of publication, comments were received from La Union Electric Cooperative, Inc. (LUELCO);

WHEREAS, during the said 62nd RCC Meeting, the RCC discussed the proposed changes, considering the comments received;

WHEREAS, during the said 62nd Meeting, after due deliberation and after satisfying the requisite criteria as provided for under the pertinent provisions of the WESM Rules and WESM Manual of Procedures for Changes to the WESM Rules, the RCC approved the proposed changes to Clauses 2.5.6.1 and 2.5.6.2 of the WESM Rules (attached as Annex "A");

NOW THEREFORE, we, the undersigned and in behalf of the sector we represent, hereby resolve as follows:















RESOLVED, that the proposed Changes to the WESM Rules Provision on Notice of
