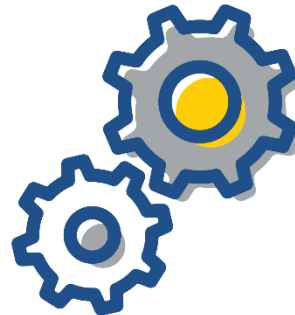

In 2019, the Rules Change Committee (RCC) and PEM Board endorsed to the DOE **nineteen (19) proposed amendments** in the following areas:

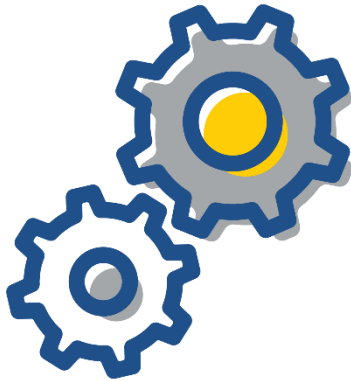
RULES CHANGES



WESM Governance

- conduct of **market audits**
- **performance monitoring** of Metering Services Providers
- calculation for measuring **forecast accuracy** of must-dispatch generating units
- implementation of **WESM Compliance Officers' Accreditation Program**

RULES CHANGES



Market Operations

- **registration** process and timelines for registered capacities, new facilities, new load facilities, embedded generators
- calculation of **initial prudential requirements**
- standards and procedures for **compliance of metering facilities**
- **constraint violation coefficients** of self-scheduled generating units
- timing of **market runs**

RULES CHANGES



Retail Market

- **registration** of Contestable Customers
- **responsibilities** of Contestable Customers, Central Registration Body, Distribution Utilities and PEMC
- **switching** of Suppliers
- requirements for **retail metering installations**

RULES CHANGES

Status:

- The DOE **promulgated three (3) rules change proposals** in June 2020 embodied in the following Circulars:

Proposal	DOE Circular	Effectivity
Provisions for Registration of New Facility and Harmonization with R.A. 11234 or “ Energy Virtual One-Stop Shop ” Act	DC2020-06-0013	02 July 2020
Provisions for Determination of Initial Prudential Requirements	DC2020-06-0014	

- Other proposals have already undergone or are lined-up for **DOE Public Consultations**

RULES CHANGES RELATED TO ENHANCED WESM DESIGN & OPERATIONS

Approval of the proposed amendments to Market Rules and Manuals on the following topics are still pending:

1. New WESM Enforcement and Compliance Manual
2. Market Surveillance and Compliance
3. WESM Penalty Manual
4. Entry and Participation in the Retail Market
5. Constraint Violation Coefficient of Self-scheduled Generation
6. Timeline of Market Runs
7. Central Scheduling and Dispatch
